- Sheila mentioned that she had been involved in the startup of a co-op in 70s that was done in the garage of one of the members. Annie explained some of the issues why that is not a viable option. (Too many competitors now, unlike in the 70s when many co-ops started. CCM couldn't even begin to compete in a number of ways.)
